Delivery of product to the undersigned's facilities may be made without obtaining signatures upon delivery. Delivery times are "best efforts" only. Flyers will not be responsible for any claims or damages whatsoever for failure(s) to deliver at certain times. Applicant's or guarantor's obligations under this agreement shall remain in full force and effect for all indebtedness incurred prior to such written notice.

The Customer further agrees that Flyers may assess a late fee of 1.5% per month (18% annual rate) on all balances over 30 days at the end of each month; a handling charge of \$30 for each returned check, EFT or credit card charge; and all collection costs and legal fees, which will be paid at our office in Auburn, California.

Customer agrees to review all invoices provided by Flyers in either electronic or printed form, and to notify Flyers not later than 15 calendar days after the date of each invoice of any errors or disputes with respect to transactions and other information reflected therein. After 15 calendar days, each such statement and the transaction therein shall be binding on Customer.
